Explanation of Responses:

- The stock is restricted stock issued pursuant to the Company's 2001 Stock Incentive Plan and vests in the largest number of shares pursuant to either (i) Time Vesting or (ii) Performance Vesting. The restricted stock vests over time at 10%, 20%, 30% and 40%, respectively, on each anniversary of February 26 for the years 2005 through 2008 ("Time Vesting"). If and when the Company's common stock closes at or above per share target prices of \$14.81, \$18.52 and \$23.14 for 20 consecutive trading days, 33% of the restricted stock performance vests ("Performance Vesting").
- The original Form 4 inadvertently reported this transaction as a disposition, rather than an acquisition.
